In the context of the above subject, you are informed that as per the PMS for SC and OBC Students Scheme, from the session 2018-19, the scholarship, maintenance allowance and management share to be given to all the Scheduled Caste students is to be paid through DBT, hence all Register and Principals is to request that all Scheduled Caste and Other Backward Caste boys and girls studying in their respective educational institutions should be instructed to link their Aadhar cards with their bank accounts and only that bank account should be used in the application for scholarship. Mention the number with which their Aadhaar number is linked and all the registrars and professors are requested to mention the award roll number of all the Scheduled Caste and Other Backward Caste students studying in their respective educational institutions while sending the certificate to the claim department. Make sure that the Aadhaar number of all the students is correct and linked to the bank account. Due to the Aadhaar number not being found correct or the Aadhaar number not being linked to the bank account, any student If it is not received, all the responsibility will be of the concerned institution. Please give it first priority.
