1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Government College Kharkhara: A Beacon of Education in Rural India

Education is not only a fundamental right but also a powerful tool for personal, interpersonal and community development. In rural areas, access to quality education is a boon that can break cycles of poverty, and foster socio-economic growth and can be a harbinger of prosperity. Government College Kharkhara stands as a testament to this belief and proves it by providing accessible, equitable and affordable higher education to the youth of the rural areas of Kharkhara and surrounding villages, empowering them with knowledge, and skills to sustain in the postmodern world.

Established in 2011, Government College Kharkhara has been a significant milestone in the educational landscape of rural Haryana and is a catalyst for change, embodying the transformative powers of education. As a relatively young institution, it has quickly grown into a reputable centre of learning, offering diverse academic programs and playing a crucial role in the socio-economic development of the region.

Since its inception, the college has made incredible strides in the field of education. Beginning from a humble start up from a temporary school building, it kept progressing despite numerous challenges such as limited resources, low GER and insufficient infrastructure. But the dedication of faculty members, staff and government's efforts laid a strong foundation for the institution's remarkable growth.

A significant change came in 2017 when the College shifted to its own state-of-the-art building. This shift not only provided the much-needed infrastructure but also marked a new era of educational excellence. **The new campus, well equipped having modern facilities with spacious classrooms**, has greatly enhanced the learning environment and academic excellence.

The college currently offers **Bachelor of Arts (B.A.), Bachelor of Science (Non-Medical), and Bachelor of Commerce (B.Com.)** catering to diverse academic interests, prospects and career aspirations of the students. **From the academic session (2024-25), this College has offered new postgraduate programs i.e. Masters Degree in Geography and Commerce, which marked a new epoch in the short journey of this college. Thus, the Government College, Kharkhara has now become a beacon of hope, prosperity and progress in the rural region.**

Vision

The vision of the college is to facilitate and empower the students of this region to dream, pursue and fulfil their academic and professional goals and to prepare them to face the challenges of modern life by moulding them into skilled, competent and confident citizens. The College also aims to create an atmosphere of collaborative and multidisciplinary learning with innovative ideas and knowledge skills set in consonance with NEP 2020. The institute adopts an all-inclusive approach that counts on students, faculty, and staff by liaising with all other fields of learning such as humanities, social sciences, commerce including corporate world. It orients students

Institutional Weakness

- Acute shortage of class four employees in the College premises to upkeep maintenance activities Also a shortage of non-teaching staff including laboratory assistants that hampers Administrative & Laboratory work in the College.
- The most students belong to rural areas of nearby villages, having less orientation towards study due to some or other familial problems and responsibilities. They later contribute to low pass percentage and drop outs.
- The college faces a great difficulty in tracking Alumni as maximum students belong to other states like

Rajasthan,U.P, Bihar etc., who later shift due one or other responsibilities to their native places.

- Parents in rural region are also less educated and have economic problems, so they always search for any job opportunity for their wards and encourage them to join any job rather than sending them to college and finally students either fail in exams or drop out from college without completing the program.

Institutional Opportunity

- Opportunities to join seminars, workshops, and Faculty Development Programs for the College Teachers as to enhance their teaching and presentation skills.
- Exploration of Alumni for assistance and institutional development.
- To develop more sports facilities for the students of rural areas as they have more potential to excel in the sports..
- More MOUs are planned to be signed with more corporate houses for jobs and internships as the college is situated between the Industrial hub of Bhiwadi, Bawal and Dharuhera.

Institutional Challenge

- **GC Kharkhara situated on NH 8 and the nearest bus stop Dharuhera, is approximately 2 to 3 kms away from the College, due to which the girl students face commutation problems to the College.**
- **Conservative thoughts of parents belonging to the rural backgrounds who restrict girls for education.**

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The Institution ensures effective curriculum delivery through a well-planned and documented process. The College has an efficient curriculum delivery mechanism which is accomplished by the faculty members in accordance with the university academic calendar. The academic session starts with the timetable which is formulated by a committee as per the work-load guidelines prescribed by the DGHE, Haryana. The faculty members of all the respective departments prepare semester-wise lesson plans and carry out their teaching accordingly. The prescribed syllabus is exhaustively covered and a revision of the same is also ensured. Various assignments, class tests are conducted for an objective assessment of the performance of students during the session. A record of internal assessment / marks of all the students is displayed on notice board before its updation on the university portal. At the end of each semester, the university conducts both theory and practical exams for the final evaluation. Thus, a well-planned curriculum delivery is ensured through careful execution and documentation.

One Certificate program “Computer Awareness L-I” offered during the last five years.

Total 54.75% students enrolled in Certificate program “Computer Awareness L-I” as against the total number of students during the last five years. The institution integrates crosscutting issues into the curriculum through

interdisciplinary courses and practical projects. The institution integrates these issues through Women Cell, NSS, Legal Literacy Cell and Eco Club, ensuring comprehensive ethical and social education.

45% of students have participated in project work and surveys. B.A. 6th semester students conducted a socio-economic survey under the supervision of Geography Department, while 1st-year students completed an environment survey as a compulsory paper.

Feedback was collected from four key stakeholders: students, teachers, parents, and alumni through both online and offline modes. The feedback then analyzed by a dedicated committee. Based on the analysis, an action taken report was prepared to address the identified issues, problems and to implement improvements. This report was subsequently reviewed and signed by the competent authority, ensuring accountability and transparency in the process. This comprehensive approach ensures that the institution remains responsive to the needs and suggestions of its community, fostering continuous improvement and engagement.

Teaching-learning and Evaluation

The college is dedicated to the holistic development and inclusive education of its students, recognizing achievements in academics, sports, and cultural activities through annual prize distribution and other felicitation ceremonies. Significant accomplishments include students ranking in Indira Gandhi University merit lists, winning at district and university-level competitions, and getting medals in state and national sports events. The college also successfully organised its second convocation ceremony in January 2024 with remarkable presence of students. The most important thing in teaching learning process of this institute is ability of its teachers to create enthusiasm, ignite passion and generate curiosity among the students. The teachers are deputed off and on to participate in various, conferences, seminars and symposia, orientation and Refresher courses to hone their teaching skills so that they can make their teaching methods more innovative, interesting and effective. The whole process of education is student-centric, and different units are framed in the College to facilitate different aspects. The lesson plan is given well in advance to enable the students to be mentally prepared for the topics to be taught during the session. Teaching methods like Student-centric approaches (e.g., project-based learning, flipped classrooms), Innovative methods (e.g., technology integration, gamification), Use of learning resources (e.g., library, online resources), Encouragement of critical thinking and problem-solving are being used. Diversification in student intake (e.g., gender, socio-economic background), Support services for students (e.g., academic advising, counselling) Evaluation of program outcomes (POs) and course outcomes (COs) is conducted using quantitative methods (class tests, assignments, quizzes) and qualitative methods (co-curricular activities, personality development). A significant portion of the assessment is based on University Examinations (80%) and Internal Evaluations (20%). The college ensures the communication and accomplishment of POs and COs through faculty efforts, orientation programs, and displaying information on the college website. Feedback from stakeholders is used to improve the educational environment, aligning with the curriculum committee's goals and practices. IQAC of the College is supported by senior faculty members who monitor all the curricular, co-curricular and extra-curricular activities in the College which ensures all the necessary support to teachers and students for better teaching and learning outcomes.

Research, Innovations and Extension

At Government College Kharkhara, we prioritize research, innovation, and extension activities to foster academic growth, professionalism and community engagement. Our faculty and students are actively involved in various research and extension initiatives that enhance their academic and social contributions.

- **Faculty Research and Publications**

Faculty members are encouraged to engage in research and innovations so as to contribute to their academic knowledge and excellence. They are financially supported and encouraged in writing and publishing research papers, particularly in UGC CARE-listed journals. The college provides opportunities for faculty to participate in Seminars, conferences and workshops, enabling them to stay updated with the latest advancements in their fields and to network with peers.

- **Student Participation in Extension Activities**

Students are actively involved in extension activities, contributing to societal welfare and gaining practical experience. Through the National Service Scheme (NSS), students participate in various outreach programs, including rallies on "Say No to Tobacco" and "Save Environment." These activities raise awareness and promote positive societal changes.

- **Outreach and Collaboration**

The college has signed three Memorandum of Understanding (MOUs) to enhance its outreach efforts and programmes. One MOU is with an industry partner, providing students with practical exposure and opportunities for internships. The other two MOUs are with healthcare professionals, focusing on dental health and gynecology. These collaborations offer students and the community an access to essential health services and educational programs.

- **Recognition and Contributions During COVID-19**

The college's commitment to community service was particularly evident during the COVID-19 pandemic. Government College Kharkhara served as a COVID-19 center, and the Deputy Commissioner of Rewari recognized our efforts with an Appreciation letter. This acknowledgment underscores our dedication to serving the community during critical times.

Infrastructure and Learning Resources

- Our College is well set up in approximately 8.5 acres/69 Kanal 13 Marla of land and provides a comprehensive infrastructure with 13 classrooms, 11 specialized labs, and a Language Lab. Facilities include two smart class room, one Seminar Hall, 1 auditorium.
- For administrative and operational purposes, the college features a staffroom, two staff toilets, and various offices such as the SC Cell, Placement Cell, Sports Office, Bursar's Room, SPIO Office, Registrar's Office, IQAC, and the Principal's Office.
- Accessibility features ramps, six bathrooms for differently-abled, and drinking water stations. Emphasizing sports, the 2-acre ground supports various activities and events. Additional amenities include a library, gym, and health room. The campus also boasts three parks, a guardroom, generator, and CCTV surveillance, fostering a holistic educational environment.
- The library at Govt. College Kharkhara, is well equipped with SOUL 2.0 software, offering a range of advanced facilities. It houses 5,164 books across various core and multidisciplinary subjects, including History (152), Geography (114), Mathematics (354), Political Science (303), Science (978), Hindi

(252), General Topics (838), Commerce (1,578), Physical Education (85), English (420), and Economics (90).

- The library, fully air-conditioned, provides digital resources, internet access, and a photocopy machine. Additional departmental libraries support specialized needs. The college was also a member of the N-LIST program, enhancing research and academic resources.
- Govt. College Kharkhara is well-equipped with IT tools and infrastructure. It features five computer labs for various disciplines, a Language Lab, and maintains its website with all information. There are 123 computers for student usage.
- The college utilizes a 50 mbps leased internet line and has a JIO Wi-Fi network with limited bandwidth. Facilities include a seminar hall with IT amenities, two smart classroom, and a multipurpose hall with advanced audio-visual equipment.
- Security of the premises is managed by 31 cameras and an NVR system. Aadhar-enabled biometric attendance, and various online portals enhance operational efficiency. Future plans include expanding smart classrooms and IT enabled resources.

Student Support and Progression

Student Support Systems at Govt. College, Kharkhara

- **Scholarships:** The college provides several scholarships to support student educational needs. Girl students achieving at least 60% marks in 10+2 and pursuing general degree courses also get scholarship. The Haryana State Meritorious Incentive Scheme rewards students who excel in annual university exams. SC scholarships offer financial aid to Scheduled Castes students, enhancing educational opportunities. The Post-Matric OBC Scholarship supports students from Other Backward Classes at the post-secondary stage. Over the last five years, approximately 1900 students have benefited from these scholarships.
- **Capacity Development and Skills Enhancement:** To inculcate skills in students various activities such as essay writing, Quizzes and poster making are organized. Training sessions on skill development, language and communication skills, and self-defence training, yoga training, lectures on crime against women, nutrition, health, hygiene are held to boost students confidence and moral.
- **Guidance for Competitive Examinations and Career Counselling:** The college has organized numerous workshops on career counselling, interview preparation, and CV writing, which have been proved highly beneficial for students to boost their careers. Students have attended job fairs as scheduled by the DGHE, leading successful placements in various companies.
- **Grievance Redressal:** The college has established several cells and committees, including the Grievance Redressal Cell, Anti-Ragging Cell, and ICC, to transparently and efficiently address student grievances. A Discipline Committee maintains campus discipline, and teachers perform proctorial duties during their vacant periods. The Registration branch handles university-related grievances while the nodal officer of Admission Committee addresses admission-related queries.
- **Awards and Participation in Sports/Cultural Events:** Many students have participated and secured positions in various cultural and sports events. Approximately 66 students have got prizes at district, state, national, and university levels in sports and cultural programs.
- **Student Progression:** Numerous students have been placed in jobs both in public and private sector while others progressed to higher education. 16 students have qualified in various State, National, and International-level examinations.
- **Alumni Engagement:** The college has its own Alumni Association named as "Samarpan Association". The association fosters alumni connections, addresses college needs, and contributes to

community projects such as tree plantation and providing online admission guidance.

Governance, Leadership and Management

The administrative set-up of the college is well headed by the Principal, who follows the rules and regulations of the Higher Education Department of Haryana and the Indira Gandhi University, Meerpur, Rewari. The college follows a democratic and participative system of governance in which the Principal of the institute conducts various meetings of the teaching, non-teaching staff and students throughout the academic year and discusses the problems and challenges before the institution. The faculty members of the college follow the advice given by the Principal and interact as and when required to work for a better academic environment in the college. The College Council takes all important decisions under the chairpersonship of the Principal.

The college has an IQAC cell headed by the Principal. In the meetings of IQAC, topics like preparation of academic and activity calendar, formation of Mentor-Mentee Groups to ensure weekly mentor classes, formation of alumni association, extension/ upgradation of existing infrastructure, maintain the records of teachers who attended OC/RC/STC/Workshop/FDP etc, organizing seminar/workshop for capacity building of teaching and non-teaching staff, to finalize API Performa of teaching staff etc are discussed. Feedback from students, parents, alumni and teachers is taken to ensure that corrective measures are taken to improve the teaching-learning environment and for implementing University policies and plans. The following steps have been implemented by the IQAC to improve learning outcomes:

5. Tests, Seminars, Assignments and House Exams
6. Workshops/Extension Lectures

The heads of all departments and the senior faculty members are actively involved in the decision-making ensuring a firm role for each member of the department.

There are considerable number of parameters to assess the performance the teaching and non-teaching staff. The performance of each and every employee is assessed after the completion of academic session. Systematic measures are adopted to gauge the capabilities and efficiencies of both faculty and staff. some of the specific parameters to assess teachers' annual performance as employed at present are, ACR, API and feedback.

Institutional Values and Best Practices

Government College Kharkhara (Rewari) values institutional values and best practices in its all walks of life. First of all the college is highly dedicated to promote gender equality, environmental sustainability, student safety and to increase GER. It also includes energy conservation, green practices, rain water harvesting and waste management. Throughout the year, the college organizes multifaceted programs and activities to ensure best practices and values.

Newly admitted students are introduced to institutional rules and regulations in the beginning of each academic session so that they can understand norms and adhere to institutional standards.

The Anti-Ragging and Discipline Committee in the college works diligently to promote a conducive teaching & Learning environment, for the freshers while protecting them from any harassment and misconduct.

The college also provides a separate common room for female students, ensuring their comfort and safety.

Effective waste management systems are in place to handle solid, liquid, and electronic waste. Additionally, a rainwater harvesting system supports water conservation efforts.

The Women Cell, Placement Cell, and NSS wings contribute significantly to instilling moral and social values in students. The various cells focus on personality development, awareness of constitutional rights, gender sensitivity, career counselling, safety, and discipline.

Monthly mentor classes provide students with a platform to discuss their problems and issues with their mentors. The use of ICT tools and smart classroom teaching in the college is encouraged to enhance the teaching & learning experience.

Two of the college's best practices include the 'Stitching Sustainability Program' and the 'Campus Shield for Girls initiative' which are aimed at women empowerment.

Through the Stitching Sustainability program, students actively participate in stitching cloth bags, promoting the use of reusable bags and saying no to single-use plastics.

2.5 Evaluation Process and Reforms**2.5.1**

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient**Response:**

Internal assessment for all courses and subjects is done strictly as per university guidelines and norms . The College conducts internal assessment throughout the session. The class teachers ensure the consistency in performance of the students by constantly monitoring their results. The internal assessment of 20 marks for UG (B.A/B.Com/B.Sc) classes are awarded as under:

1.Class Test: 10 marks

2.Assignment: 5 marks

3.Attendance: 5 marks

- Periodic Surprise tests are conducted to ascertain the progress of students in their studies as per the discretion of class teacher, generally once or twice in a semester.
- Class Assignments offer teachers a chance to assess students in more innovative ways.
- To ensure transparency, the students are provided with an internal assessment schedule from time to time. Final score is also put on the Notice Board.
- Allotment of internal marks is decided by the Class teacher and checked by the HODs and the Principal before updating it on the University Portal. After evaluation , the record of assessment is maintained by the concerned teacher.
- The academic performance of the students is evaluated continuously by the teachers through various means such as performance in class test, presentations, group discussions, project reports etc.
- The College strictly adheres to the academic calendar as per the University norms. The institution is committed to ensure value education and provides an academic atmosphere free from unfair-means. The menace of using unfair means in exams is totally curbed with the help of faculty members , flying squads and university authorities. The principal has also constituted a committee of senior faculty members to check and control any kind of malpractice during the University examinations.
- The College has adopted three tier system to address the examination related grievances of the students. Depending upon the nature of grievances, the three tiers include Department/faculty level, College administration level . At the College level, a committee of senior teachers has been constituted to take up the grievances of the students regarding filling of online examination forms, result-late issues, re-evaluation issues and any discrepancy observed in the mark sheet of the students. Apart from these, Discipline committees are appointed by the College administration for the smooth and fair conduct of university semester examinations. - The program outcomes are assessed with the help of various methods like home assignments, class tests, and university examinations, practical's, group discussion, participation in class activities.
- Students are motivated to participate in various competition, seminars and conferences etc.
- The efforts are made by the faculty members to achieve the outcomes as envisaged by the curriculum committee. During the orientation the content of the course, its importance and relevance is discussed in details.
- **The College adopts the following two frameworks to assess the Cos and POs:**

1. Quantitative Framework- This framework is based on the performance of the students in day to day classroom teaching -Learning process. Response:

Our College is situated on an expansive 8½ acres (69 Kanal 13 Marla), offering a well-equipped and diverse infrastructure to support both academic and extracurricular activities. The campus is designed to cater to a wide range of needs, ensuring a conducive environment for learning and development.

Academic Facilities:

The academic infrastructure includes 13 classrooms that are well-equipped for interactive learning. The college boasts 11 specialized laboratories catering to various disciplines: three for Geography, two each for Physics and Chemistry, two Computer Labs, one math lab and one Commerce Computer Lab. Additionally, there is a Language Lab designed to support language learning and proficiency.

Teaching and Learning Spaces:

For enhanced teaching and learning experiences, the college has two smart class rooms equipped with advanced IT resources to support modern educational methods. The Seminar Hall, with a seating capacity of 90, is used for workshops, guest lectures, and academic presentations. The auditorium/multipurpose hall serve as venues for larger events, including cultural activities, and convocations.

Accessibility and Amenities:

The campus is designed with accessibility in mind, featuring ramps for differently-abled individuals to ensure ease of movement. There are six bathrooms, split evenly between boys and girls, each equipped with five seats. For differently-abled persons, there are six specially designated bathrooms. Additionally, the campus includes three motorized drinking water stations to ensure ample hydration for students.

Sports and Recreation:

Our college places significant emphasis on sports and physical education. It has a 2-acre ground area that accommodates various sports facilities including a playground for Kabaddi, Kho-Kho, Cricket, and Volleyball, as well as an athletic track. There is also open space designated for Yoga. The college organizes an annual two-day sports athletic meet in the month of October or February, and also celebrate National Sports Day. Students participating in these events receive necessary sports kits

and materials, and travel reimbursements are provided as per government norms.

Additional Facilities:

The campus is equipped with a range of additional facilities to support student and staff needs.

- These include a well-stocked library, a gym, a girls' common room, and a health room.
- For administrative and operational purposes, the college features a staffroom, two staff toilets, and various offices such as the SC Cell, Placement Cell, Sports Office, Bursar's Room, SPIO Office, Registrar's Office, I.Q.A.C., and the Principal's Office.
- There is also an administrative block for managing day-to-day operations. For security and backup, the campus has a guardroom, a generator set, and a reliable electricity supply. The whole campus is covered under the surveillance of CCTV.

Green Spaces:

In addition to these facilities, the college grounds include three parks, offering green spaces for relaxation and leisure. The aesthetic and functional design of these parks contributes to a pleasant campus environment.

Not only routine Life IT supported well in crucial period. The field of Education is also blessed with its strength and versatility.

- In Govt. College Kharkhara there are five computer labs i.e. Two computer labs for Arts and Science Stream and one Computer Lab is for Commerce Students and one computer lab is for the students of Mathematics, for the betterment of communication skill college established a Language lab . These labs are governed by the well qualified staff under the observation of higher authorities. The maintenance work of the labs are done by the Local technical support from Dharuhera or Rewari.
- College is maintaining it's website properly and all the relevant and important information are uploaded in the interest of Students and Staff members and the users.
- By the direction of D.G.H.E, Haryana, the college has 50 MBPS Lease Line for Internet Connectivity. The wired connectivity is provided in all the rooms to access the Internet.
- JIO Wifi network is also available in college but it is under the constraint of very low data limit and bandwidth of 8-10 MBPS only.
- College has one well furnished seminar hall , having IT facilities like Projector, Sound System, Podium and a wall screen Guest Lectures, meetings and on line broadcastings .
- There is one smart class room having Podium and Smart Board and Internet Connectivity.
- College has one multipurpose hall for the cultural, academic events. This hall is equipped with the wall mounted Projector , A strong sound system of 7 wired mic and two cordless mic and a sound mixer of 16 channels along with a amplifier and four wall mounted speakers. This multipurpose hall is connected with 50 MBPS Internet Line.
- For the security purpose college is covered with 31 cameras governed by one NVR of 32 channels and 8 POE and a Hard drive of 1 TB.
- For attendance college is running Aadhar Enabled Biometric Attendance System, Two FM220 U Startek finger print scanner are installed in college office.
- The college Library has a Computer system along with Printer Scanner and UPS for the smooth functioning of Library System. Soul 2.0 is installed in the library for the book searching, issue and return and many other Library related process. More than four thousand books are being managed and supported by Automation System.
- Many departments and cells like Placement Cell , RTI Cell , Bursar, Registrar , N.S.S, Commerce, Geography, Physics, and Principal's Office are using Computer , Printer and scanner along with Internet.
- On line Admissions, ACR , MIS, HRMS,ERP, AISHE, AEBAS , Various Scholarships etc. are

being run and governed by On line Portals. In the future number of smart class rooms, Announcement system, Computers are to be established in coming session .

Non-Teaching Staff: The ACRs of the Non-Teaching staff are offline. The first Appraisal authority is the HOD/Head Clerk, and the Principal is the second Appraisal Authority. The Final Appraisal Authority is the Joint Director, Office of Higher Education Commissioner.

There is prescribed Academic Performance Indicator (API) Performa for self-appraisal filled by the faculty members and verified by the IQAC. The teachers are required to obtain minimum API score covering all the three categories of API Performa for the promotion under Career Advancement Scheme of UGC and Haryana Government.

At the end of academic session feedback from the students is obtained containing the qualitative and quantitative parameters of teaching learning. The outcome of the feedback analysis is conveyed to each

teacher for their encouragement and to take necessary action for improvement if necessary.

Being a Government College, the Government of Haryana offers the following welfare schemes for all its employees. The orders are issued by the Department of Higher Education, which the college strictly follows. The institution places a significant emphasis on ensuring the well-being and job satisfaction of its teaching and non-teaching staff through a well-rounded framework of effective welfare measures. 6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

Mobilization of Resources:

The College adheres to Haryana's accounting standards and laws and having two source of income: one is receiving financial support from the Haryana Government and the other is fee received from students

admission under various funds like AF, Youth Welfare, Magazine, University, commerce fund etc. some times college also receive items like computers, computer table, books etc. directly from the Higher Education Department

Utilisation of resources:

The Principal discusses departmental needs in staff meetings, with teachers and committee conveners submitting their demands. An estimated proposal budget, prepared according to government norms, is sent to the Competent Authority for approval, ensuring ongoing maintenance and enhancement of labs, library, and facilities.

To utilise the grant and funds Principal forms a purchase committee as per grant instructions, strictly adhering to government financial rules for procurements. Purchases are preferably made through GEM (Government e-Marketing) to ensure transparency. The committee can also invite quotations, compares rates, and obtains approval from the Principal, issuing supply orders to the lowest bidder. Purchased items are recorded in the stock register after physical verification by the committee for effective fund utilization. At the session's end, a stock verification committee, appointed by the Principal, reviews the available records. This committee may recommend auctioning non-operational items. The office staff maintains the cash book, which is regularly verified by the Bursar and attested by the Principal.

The Principal, Bursar, and clerk handle financial documentation and bills transparently and efficiently.

Audit:

External Audit:

The audit team of the Accountant General of Haryana and the Higher Education Department, Panchkula, periodically review financial records, use of grants as per norms, and general fund revenues and expenses to ensure accuracy and compliance. The report of Audit is submitted in college and in case of discrepancy report will be sent to Higher authorities and clarification is submitted by the college to remove the audit para.

Internal Audit:

The college's Bursar verifies and confirms all transaction vouchers according to the budget and available various funds, ensures financial integrity, and advises the Principal on record-keeping. The college Bursar plays a crucial role in verifying and examining the fees collected from student admissions across various funds, such as the Computer Fund, AF, Youth Welfare Fund, RK Fund, University Fund, and EVS Fund etc. During the admission process, students submit their fees online, which are initially credited to the Higher Education Department's account. Upon completing the admission process, the department transfers the collected amount to the college, after deducting any applicable late fees. The FTR (Fee Transfer Report) Committee then prepares a detailed FTR report, summarizing the transferred amounts. The Bursar reviews this report to ensure accuracy. If there is a discrepancy between the amount received and the expected amount based on student enrollment, the Bursar prepares and submits a demand for the correct amount to Higher authorities.
